# SOME EXAMPLES FOR YOUR REFERENCE :-

1. If a **new downline** does **150 PV** in **April 2024** and **150 PV** in **May 2024** then Foster will get **150+150=300 PV OR 3 point.**
2. If **two new downlines** do **150 PV each** in **April 2024** then **100 PV** per downline will be considered and Foster will get **100+100= 200 PV OR 2 points.**
3. If a **new downline A** does **120 PV** in **April 2024** and **100 PV** in **May 2024** and his another **new downline B** does **180 PV** in **April 2024** only then Foster will get **120+100=220 PV i.e. 2 points** from **Downline A** and **180 PV i.e. 1 point** from **Downline B** i.e. in total Foster will get **3 points.**
